PULL KNOB, GET ART!



Art*o*mat® at Frost Art Museum, Miami, Florida

When someone thinks of vending machines, they typically visualize gumballs, cheap toys, snack foods, sodas and cigarettes. The Art*o*mat® project is designed to encourage people to think of art. Sculptures. paintings, photographs, collages, jewelry and other artforms are made to fit in small. cellophane covered cardboard boxes and dispensed via retired cigarette vending machines. After inserting money and pulling the knob, you walk away with an original work of art by one of 400 contributing artists from 10 countries.

Created in 1997, there are

71 active machines in museums and various locations throughout the United States. The Cleveland Center for Contemporary Art is the only host in Ohio to date.

The inspiration for
Art*o*mat® came to artist Clark
Whittington of Winston-Salem,
NC as he was preparing for a
solo art show at a local café.
A friend glanced through his
sketchbook and noticed a
sketch of a vending machine
and suggested he use it to vend
his artwork. In June 1997 the
first Art*o*mat® was installed
with 12 of Whittington's

BUILDING CONNECTIONS

In its second year, the state's largest history-related gathering, Building Connections: Ohio's 2004 Conference on History, Preservation & Revitalization was held November 4-6 in Columbus.

Nearly 700 people with an interest in the history of Ohio attended, including historical organizations, archivists and preservation advocates.

Featured speakers included James B. Gardner of the National Museum of American History; Thomas Hylton, Pulitzer Prize-winning journalist; and U.S. Representative Ralph Regula, dean of Ohio's Congressional delegation and a senior member of the U.S. House of Representatives.

The event was a collaboration of the Ohio Historical Society and the Ohio Historic Preservation Office, with Downtown Ohio, Inc., Heritage Ohio, the Ohio Academy of History, Ohio Arts & Sports Facilities Commission, Ohio Arts Council, Ohio Association of Historical Societies and Museums, Ohio Humanities Council, Ohio Preservation Alliance and the Society of Ohio Archivists.

RIFFE GALLERY PRESENTS DESIGN FOR THE AMERICAN STAGE

Design for the American Stage: Treasures from the Jerome Lawrence and Robert E. Lee Theatre Research Institute will be on view at the Ohio Arts Council's Riffe Gallery February 10 – April 17, 2005. Curated by Nena Couch of The Ohio State University Theatre Research Institute and Department of Theatre.

Drawn from the extensive design collection at The Ohio State University's Lawrence and Lee Theatre Research Institute, this exhibition brings the magic of the stage to the art gallery.

The artworks for professional productions across North America represent a range of theatre design from renderings by the Armbruster Scenic Studio (1875-1958) based in Columbus to Raoul Pène Du Bois's Tony Award-winning set designs for the 1953 *Wonderful Town*. A three-dimensional model by Broadway designer Tony Straiges and a glorious painted dance floor by artist Caroline Beasley-Baker for the Bebe Miller Dance Company will be on view as well as designs for Kenley Players of Dayton, Contemporary American Theatre Company in Columbus and designs for the Metropolitan Opera, New York City.

The Ohio Arts Council's Riffe Gallery showcases the work of Ohio's artists and curators, exhibitions produced by the Ohio Arts Council's International Program and the collections of the region's museums and galleries. The Riffe Gallery's Education Program seeks to increase public appreciation and understanding of those exhibitions.

WOSU STATIONS AND GCAC ANNOUNCE PARTNERSHIP

The WOSU Stations and the Greater Columbus Arts Council (GCAC) have agreed to collaborate in a partnership designed to develop a greater appreciation of the cultural opportunities available in central Ohio. Broadcast and web programming will be created and distributed through the joint resources of WOSU and GCAC.

The project will employ three positions at WOSU.TV — two arts producers and a student intern — to create a cultural arts production team focusing primarily on producing programs in the areas of performance, documentary and community profiles. Some of the programs also may be aired on WOSU Radio and through the WOSU and GCAC websites.

"This innovative community partnership is a great opportunity for both WOSU and GCAC that will serve as a model for other public stations," remarked WOSU General Manager Tom Rieland. "We've formed a true collaboration with the common goal of bringing the rich cultural resources of Columbus to a broader audience through all of WOSU's media resources."

"GCAC and the central Ohio cultural community are excited about the opportunity to show the public our vibrant cultural life in a new way," says Ray Hanley, president of the Greater Columbus Arts Council.

The OAC's Riffe Gallery is among the participating arts organizations. The programming will allow the Riffe Gallery to increase community awareness of the gallery's exhibitions, programs and special events. "WOSU has always been an important community partner," said OAC executive director Wayne Lawson. "This project will help us reach new audiences and remind long-term patrons of the value and uniqueness of the Riffe Gallery and its diverse exhibitions. The collaboration will deepen the relationship of various members of the arts community and its supporters."
