The 2005 Governor's Awards for the Arts in Ohio will be presented on April 6, 3:30 p.m. at the Capitol Theatre in the Vern Riffe Center for Government and the Arts in Columbus. Winners were selected from 60 nominations submitted by individuals and organizations from around the state. Awards will be presented at a ceremony honoring winners and members of the Ohio Legislature hosted

by the Ohio Arts Council and Ohio Citizens for the Arts Foundation. Winners will receive an original work of art by Ohio printmaker Nicholas Hill. The Governor's Awards ceremony will be held in conjunc-

tion with Arts Day. This daylong event demonstrating public value and support for the arts is sponsored by Ohio Citizens for the Arts Foundation. Arts Day will include an arts advocacy briefing, legislative visits, workshops, Statehouse tours and student exhibitions.

Arts Day was created to foster a greater awareness of the public value of the arts in Ohio. Citizens are encouraged to participate in Arts Day by visiting with their state legislators and communicating the need for public support of the arts and arts education. A MESSAGE FROM OAC'S EXECUTIVE DIRECTOR

Dear ArtsOhio Reader:

On February 8, Governor Taft released his recommended 2006 - 2007 biennial budget. The Governor's proposal for FY06/07 would reduce the OAC's budget to \$20,476,322. The OAC has received a 10% reduction from the current biennium, a reduction of 37.5% since 2000. This would be the lowest budget since the 1992/1993 biennium

This year the OAC celebrates its 40th anniversary.

Since 1965 the Ohio Arts
Council has maintained a basic
philosophy of support and
accessibility for all, responding
to both opportunities and challenges with strategies for inclusion and participation. Despite
this recommended reduction,
the Ohio Arts Council will continue to communicate the public value of the arts and the
important role the arts play
across the state.

Over the next several months the Legislature will be

debating the Governor's proposed budget. It is vital that you communicate the importance of public funding for the arts and the OAC's support to you and your organization. The role you play will make a difference!

TWO ARTS ORGANIZATIONS MERGE THEIR OPERATIONS



Americans for the Arts and Arts & Business Council Inc. announced recently that the two organizations will merge their operations, creating the largest-ever advocacy group for the arts in America. The merger will allow the organization to increase its efforts to secure increased funding for the arts from the private sector. Americans for the Arts, based in Washington, DC, is the nation's leading nonprofit organization for advancing the arts in America and has led national public-sector advocacy efforts for many years. Arts & Business Council Inc., headquartered in New York City, is the oldest arts and business partnership association in the world, devoted to stimulating partnerships between the arts and business that benefit both sectors and the communities they serve.

The resources and programming initiatives of both organizations will be combined into a powerful integrated operation. It will stimulate increased support for the arts from individuals, corporations and foundations through the development of innovative programming and the recruitment of national partners.

"This merger is a great step forward for the arts in America," stated Robert L. Lynch, president and CEO of Americans for the Arts. "Our two organizations have shared interests and great strengths, and we will be more effective together than we could ever be separately."

Both organizations recognized the challenges facing the arts today and recently completed strategic plans that emphasized, among other things, the need to increase private-sector support for the arts and arts education in America. Rather than pursue their efforts separately, the decision was made to join forces. Both the board of directors of Americans for the Arts and the board of directors of Arts & Business Council Inc. unanimously voted to approve the merger. Arts & Business Council Inc.'s national operation will be known as the Arts & Business Council of Americans for the Arts. OPPORTUNITIES

The **Artists Exploration Fund.** made possible by a generous grant from the Doris Duke Charitable Foundation, is designed to enable individual performing artists to pursue opportunities abroad that will further their artistic development. The fund is administered by Arts International. Grants, ranging from \$1,000 to \$3,000, support a variety of activities including the development or expansion of creative relationships with artists and arts organizations, the exploration of artistic forms, or the creation of new work. Eligible expenses may include travel, per diem, and other essential costs. Travel to any country outside the United States and its protectorates is eligible. Applicants must be individual performing artists with U.S. citizenship or permanent resident status. Applications will not be accepted from students, scholars, curators, presenters, administrators or critics. Guidelines for the Artists Exploration Fund are available on the Arts International website or by request. The application deadline is April 7, 2005.

ARTSOHIO GOES ELECTRONIC
