# JULIE S. HENAHAN HIRED AS OHIO ARTS COUNCIL EXECUTIVE DIRECTOR



The Ohio Arts Council Board has chosen former Ohio Arts Council Deputy Director Julie Henahan as the new OAC Executive Director. Henahan had been serving as Interim Executive Director since early April of this year when Wayne Lawson, former OAC Executive Director, retired.

"I am honored and very happy to accept this challenge and appreciate the Council's trust and confidence in me to oversee the continuing legacy at the Ohio Arts Council. With the support and hard work of the Ohio Arts Council board and the experience of a talented staff, I look forward to working with the Governor's office, legislature, Ohio arts organizations and artists to carry the mission of the Ohio Arts Council to the citizens of our wonderful state and to sharing

that mission with our regional, national and international partners."

Henahan is a long-tenured member of the Ohio Arts. Council staff with nearly 22 vears experience as an arts administrator, From 1994-2002. Henahan served as the OAC's Grants Office Director where she was responsible for the development of all procedures and policies related to the grants review process and managed the OAC's internal accounting of state subsidy funds as well as its federal funding. In addition, her recent role in leading three important projects at the Ohio Arts Council demonstrates her knowledge of the national arts environment, professionalism and capability to take the agency to new heights.

Henahan was one of five OAC staff members selected to participate in the Wallace Foundation's program for a State Arts Partnership for Cultural Participation (START) grant award. The focused work that resulted from this grant allowed the agency to streamline its granting programs from 24 to seven. She guided the agency through the implementation of the new OnLine Grant Application system (OLGA) and the agency's (con't page 2)



# EXCITING INDIAN DANCE COMPANY PERFORMS IN OHIO



Classical Indian dance will unite with original contemporary choreography as part of a performance series in Ohio communities this fall featuring Ragamala Music and Dance Theater. Ragamala is touring the state as part of the Ohio Arts Council's International Music and Performing Arts in Communities Tour (IMPACT).

Ragamala will perform six shows, November 6–16, 2006. Performance locations include Nelsonville, Springfield, Greenville, Sidney, Akron and Elyria. All performances are free and open to the public.

IMPACT is presented by the Ohio Arts Council (OAC) in partnership with the Ohio Arts Presenters Network (OAPN) and Arts Midwest

Founded in 1992 by Artistic Director/Choreographer, Ranee Ramaswamy, Ragamala Music and Dance Theater is dedicated to preserving the South Indian classical dance form of Bharatanatyam while using it as a springboard for innovative choreography. Ragamala's vibrant classical work and pioneering cross-cultural collaborations demonstrate the versatility, depth and contemporary vitality of Bharatanatyam to diverse audiences.

Ragamala's 2006 performance, *From Temple to Theatre*, takes audiences on a journey through time, presenting both classical Bharatanatyam and highlights of the company's stunning contemporary collaborations. Set to diverse musical influences, from the soulful classical music of India to the thundering drums of Japan, from stirring original poetry to the á capella vocalizations of Zap Mama, this program is sure to please all audiences.

### THE ARTS BENEFIT YOUR COMMUNITIES

The Ohio Arts Council has been providing public value to the people of Ohio for more than 40 years. With this long history of success, the work of the Council reaches each of the state's 88 counties, ensuring all Ohioan's can participate in the arts.

Since 1965, the Ohio Arts Council has been recognized nationally as one of the finest state arts agencies in the nation. The reasons for this success include: a supportive Legislature and governor; an open panel process which allows constituents to hear the review of their applications and provide feedback to the Council on our process and policies; a long tenured, gubernatorially appointed Council Board; a wide array of programs which support some of the largest arts institutions in the state as well as small emerging arts organizations and individual artists; and one of the best arts in education program in the country.

During the last 40 years the state has made a strategic investment of public dollars through the Ohio Arts Council's arts education program. Arts education involves the simultaneous use of a range of intellectual activities that is not possible in other academic disciplines from expressing ideas, thoughts and feeling in both concrete and abstract forms to developing and exercising judgment.

Arts education programs are also an effective strategy for troubled youth who have failed to respond to more traditional education programs, improving the attitudes young people have about themselves and learning. In recognition of the need for Ohio students to develop the skills and gain the knowledge that will make them competitive in the changing and global work environment, through your legislation, the Ohio Department of Education has mandated arts standards.

One of the most important features of legislative investment through the Council is that most grants are awarded on a matching basis. That means that public dollars must be matched on a 1:1 basis by other resources, public or private, raised by recipient organizations. By requiring this match the OAC is encouraging recipient organizations to leverage OAC funds to generate new sources of income to broaden their bases of financial support. In reality, Ohio Arts Council grants are matched by private dollars on an average of 28 dollars to every one state dollar. OAC funding stimulates private giving and local economies. No other state agency has so successfully leveraged its capitalization to enhance the creation of income, employment and opportunities for corporate investment in the state. Thank you for your support of the arts in Ohio.
